ACKNOWLEDGEMENT, LIABILITY WAIVER

I understand and acknowledge that there is potential risk involved in the training for, and participation in, any physical activity, including any event hosted, organized, administered, sponsored by, or otherwise involving, the Canadian Adult Recreational Hockey Association ("CARHA Hockey"). While rules and guidelines may reduce the risk associated with participation, the risk of serious illness, injury and death does exist. I freely accept and acknowledge all risks, dangers and hazards resulting from my participation in, or attendance at, any event hosted, organized or sponsored by CARHA Hockey.

I am also aware that I should discuss my participation in any CARHA Hockey activity with my physician to determine any potential effect on my health. It is my responsibility as a participant to immediately remove myself from participation and notify the nearest official, if at any time I sense any unusual hazard or unsafe condition or if I feel that I am physically, emotionally, or mentally unfit for continued participation. I acknowledge my responsibility to ensure adequate medical personal health, dental and accident insurance coverage, as well as protection of my personal possessions.

I hereby agree to release, remise, waive and forever discharge all claims that I have or may in the future have against CARHA Hockey, its coaches, officials, members, agents, directors, officers, employees and representatives, and other participants (all of whom are hereinafter collectively referred to as "Releasees") with respect my participation in, or attendance at, any event hosted, organized or sponsored by, or otherwise involving, CARHA Hockey, howsoever caused, including negligence of the Releasees. I am aware that by signing agreement I am waiving certain rights I may have against the Releasees and that this release is binding on my heirs, executors, administrators and assignees.
